Applicants must fill in the attached application form and mail it with a copy of their ID card or passport to the address summerschool@jus.unibs.it or fax it to +39 (030) 2989613. Applicants will be selected by a Committee appointed by the Faculty. Successful applicants will be notified.

Application deadline

15 June 2012 or later, subject to availability.

Tuition Fee, Registration

There will be no tuition fee for students registered at a University or a Law School (including PhD and Master students). A tuition fee of 100,00 euros per day is required to other applicants (400 euros for the whole week).

A limited number of scholarships (covering accommodation and meals) is available for foreign candidates, accepted to the program and registered at a non-Italian university. The University can provide a list of accommodations at low rates for all applicants.

Transport and facilities

Information to help students to travel to and from Brescia will be available on the Summer School website. For students coming from abroad (Europe) the most suitable option is flying to Orio al Serio Airport (Milan-Bergamo) or Valerio Catullo Airport (Verona). Low cost company fly to both airports, 45 minutes away by car from Brescia. Buses and coaches run between the airports and the town centre (close to the University and to the accommodations). For overseas students (US or other regions) the best solution is to fly to Milano Linate Airport or to Milano Malpensa Airport.

As years go by, the European Union and its Member States very often have to tackle problems deriving from the dialectical relationship between competition law and protection of social rights. These problems, which are at the very heart of European integration, concern different sectors of legal regulation, including not only European and International law but also Civil Law, Labour Law, Tax Law and Administrative Law. This course aims to give students and legal experts a general overview of EU competition law and an opportunity to explore the tensions between economic freedoms and fundamental social rights, as well as the attempts to find a balance undertaken by European and national institutions. The program will provide a theoretical and practical training on some selected issues, such as the consequences of abuse of dominance, the relationships between state aid, preferential tax treatment, procurement law and the protection of social rights, the delivery of services of general interest and green clauses. The final goal is to promote an understanding of the legal and social conditions within which the European economic system can evolve while maintaining social cohesion.
