Introduction

This initiative aims to commemorate the late Emeritus Professor **Roger Blanpain** (°5 November 1932 – †11 October 2016) by bringing together international scholars and by setting up the **100th Bulletin of Comparative Labour Relations**, a series started under his initiative in the seventies, together with an **international conference**. This means that we wish to examine evolutions, concepts, ideas or new challenges that we identify as having (had) a major impact on the way how we (have to) understand and approach labour law.
