Introduction

Distinguished ISLSSL Members,

As announced in the ISLSSL Bulletin no. 145, next June, from Sunday 18 to Saturday 24, 2017, will take place in Venice, Università Cà Foscari, the 4th International Seminar on International and Comparative Labour Law.

The 2017 edition of the Seminar will be dedicated to the issue of *Global Trade and Social Rights*.

All Seminar's participants are invited to take an active part in the discussion, from an interdisciplinary perspective.

In particular, the program of the Seminar provides that on Friday, 23rd June a session will be dedicated to the presentation and debate on the papers presented by the ISLSSL Young Legal Scholars.

This call for papers and participation is an invitation for the Young Scholars to take part in this Session with the aim to offer contribution and to represent opinions and points of view about the issues of the Seminar.

The main fields of analysis have been identified by the Seminar's Organizers in the issues of *Global Trade after Brexit and New Protectionism; Free trade or fair trade?; Social clause: models and experiences; International organizations, Multinationals and social conditionality*.

Of course, the interested scholars will be able to choose some different perspectives of analysis linked to the general theme of the Seminar.

INFO FOR SCHOLARS WHO COULD PRESENT ABSTRACT AND PAPERS FOR THE 23rd JUNE

SESSION/DEADLINES/DIMENSION

This call for paper/participation is aimed to all the Labour Law Scholars who meet the requirements provided by their respective National Association to be considered as Young Scholars.

They could submit their abstract (no more than 1.800 characters, including spaces, with concise title), within the deadline of May 31, 2017: the abstracts will have to be sent to the both addresses stefanobellomo@mmba.it and islsslseminar@gmail.com. The abstract will be examined by the Venice Seminar Organizer in a few days after receipt. If the abstracts will be accepted, the full papers (no more than 30.000 characters, including spaces, footnotes and appendix) will have to be presented in the session of 23rd June 2017.

PARTICIPATION IN THE WHOLE SEMINAR OR IN THE SPECIFIC SESSION of 23rd OF JUNE

The Young Scholars have the option to choose to attend the whole Seminar (and in this case they could ask to their National Association to submit their candidature for the scholarships): it is possible to read the complete program and conditions of participation at the web address
