A residential summer school in English, for doctoral students of the Universities of Ferrara (section of Rovigo) and Padova, open to other Italian and foreign PhD students or equivalent; to be held in Monteortone, Abano Terme, Padova (Casa di Ospitalità San Marco). Competitive admission.

Time: 4th - 15th September 2016

Topic: **Labour and Enterprise in the European and International context.**

The seminar aims at thoroughly discussing and studying all the issues related to the present regulation of modern multinational and transnational companies and related topics on social and business law, with particular reference to **Labour and Governance in Multinational Enterprises**. The focus will be on European and International practices developed in a comparative and International (private) law context.

Each guest professor will give two lectures of 3 hours (9.30 – 12.30). On a day to day basis all the participants will discuss the morning's lectures under the guidance of *tutores*. Students already researching topics related to the lectures have the opportunity to discuss their research during afternoon seminars.

The choice of topic for the lectures will be left to the professors whilst a coordination will be guaranteed by the *tutores* who will take care, before the start of the Summer School, of scheduling: lectures, seminars and special participation of students.

The School is organized by Gian Guido Balandi (University of Ferrara) and Adriana Topo (University of Padova) on behalf of the Doctoral Schools and supported by Fondazione "CARIPARO". Grants cover residential cost for 20 PhD students: approximately half from the University of Ferrara in Rovigo and Padova Doctoral Schools and half from different Italian or foreign Doctoral Schools. Participants are selected under a competitive process.

Doctoral students in Employment and Labour Law and Business Law are invited to apply by **May 21st, 2016**, with a brief statement on their interest in participating, a recent CV, a synthesis of their PhD dissertation project, a letter of recommendation and a certification of their language ability, emailed (in only one zipped folder with Name + Summerschool 2016) to summerschool.feropd@unife.it.
