**The Kutafin Moscow State Law University's** history goes back to December 1931 when Russian Government made a decision to widen higher legal education in order to provide the state with sufficient number of qualified lawyers.

Over the years, the University has trained and graduated more than 180,000 professionals with a law degree, many of whom are renowned, honored lawyers and prominent academics.

Currently, about 18,000 students are training in the main fields of law, e.g. Jurisprudence, National Security Law, Judicial and Prosecutorial Activities. 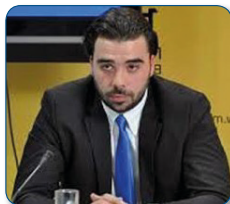

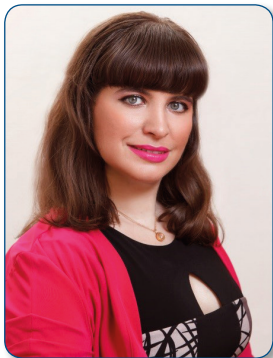

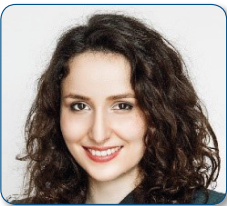
