



LLC 4TH ANNUAL CONFERENCE CALL FOR PROPOSALS

Theories, phenomena, forms, and rights of labour.
A multidisciplinary approach
15-16 November 2024 @ Bari, Italy

The changing economic structures of the world, along with a phase of accelerated technological evolution, are making the labour landscape increasingly varied. Scholars from various disciplines are investigating these changes, sometimes in dialogue with each other and sometimes not, both within and beyond national borders. Labor law scholars are also part of this discussion, which concerns the prospects of humanity, also in relation to questions about the philosophical and practical attitude towards the environment in which the species lives.

Labour Law Community – LLC has decided to place the scientific discussion accompanying its annual assembly in an open meeting space, addressing all the topics that labour law scholars, practitioners, and also scholars from related disciplines, wherever they exercise their reflection or activity, wish to propose for common attention.

By way of example, proposals may be accepted on:

- Why to work? The meaning of work, rejection of work, working conditions
- Disintegration of the enterprise, supply chain, working conditions
- Algorithm and work: performance control and depersonalization of managerial prerogatives
- Labour exploitation, migrations, climate change
- Work and feminisms
- The regulation of work among international, supranational, and national sources: where is the effective protection of labour located?
- Spaces and times of work

Panel e Abstract Proposals

Those interested in participating in the Call may send, according to the modalities indicated below:

A) A panel proposal, of a maximum of 8,000 characters (including spaces), involving at least 3 participants; the proposal should include: the general theme, the specific topics to be discussed, the names of the participants, the organization of affiliation, and their role in the panel (speakers, discussants, etc.). Proposals can involve, in addition to theoretical analyses, case studies, best practices, collective agreements, memorandums of understanding aimed at the preventive management of the phenomena addressed by the conference and the discussion of their impact on work.

Panels can also consist of:

-The presentation and discussion of a recently published monographic work on the topics discussed at the conference;

-The presentation, including via poster, of an ongoing or advanced research project, to promote the circulation of ideas and the opening of a discussion.

In both cases, the proposal must involve at least 3 participants, indicating their names and affiliation, as well as their role in the panel (author, discussant, etc.).

B) Individually, an abstract of a maximum of 3,000 characters (including spaces), centered on a theme related to one of the conference's discussion topics. The proposal should include the name and affiliation of the proposer.

Please note that:

- Based on the number of accepted proposals, parallel sessions may be scheduled, and it may be necessary to limit the duration of each session (but not below 60 minutes);
- Preference will be given to proposals involving multiple participants already in the design phase;
- Special attention will be given to proposals from (or involving as speakers) early career scholars;
- A participant can submit only one proposal but may be involved in other panels;
- The plenary session will be held in Italian; panel sessions can be held in other languages (simultaneous translation is not necessarily guaranteed).
