LLC Early Career seminars on Comparative Labour Law – ECOLL 6-9 October 2024 – Aeolian Islands (Italy)

## What is LLC?

LLC-Labour Law Community is an association of labour lawyers established in Italy since 2020 aiming inter alia at: a) promoting research and teaching in the field of labour law and disseminating the culture of labour law in the university and social spheres, also through the comparison of methods and topics in the various areas of commitment of labour lawyers; b) fostering the scientific debate at national and international level among academics, scholars, experts, and practitioners of labour law, according to canons marked by pluralism and transparency of ideas and orientations; and c) enhancing the study of labour law amongst new generations scholars with the aim to foster development of international relations in the field of labour research.

### What are the ECOLL Seminars?

In the framework of its 2022-2024 work programme, LLC has initiated a cycle of **seminars dedicated to early career scholars** (including, but not limited to, PhD students). The seminars have a twofold character: on one hand, the seminars promote comparative labour law methodologies; on the other hand, they aim to nurture the dialogue between early career scholars and more established researchers. Through the ECOLL seminars, the links between academics and research centres belonging to different legal cultures are fostered. Furthermore, early career scholars have a chance to build their own intellectual trajectories, to expand their knowledge on labour law in a comparative perspective, and to build their own research methodology, in cooperation with their peers who do research in other universities.

### How will the ECOLL Seminars be organised?

In order to achieve the aforementioned aims, the structure of ECOLL seminars is ideally as follows:

a) First part (half-day/morning): theoretical background provided by established scholars.

- b) Second part (half-day/afternoon + next-day/morning): group-work around practical case studies.
- c) Third part (half-day/afternoon): restitution of results by the groups and open discussion.
- Established scholars will be called to animate the first part which will indeed take the form of a proper conference and will also be asked to provide participants with some essential readings. LLC members of the International Relations Group will animate the Second part (group-work around a practical case study) and facilitate the final restitution of results during the Third part.
- d) Fourth part (Half-day/morning): presentation of PhD works (for those who wish to).

### Who can participate into the ECOLL Seminars?

# The ECOLL seminars are open to all labour law scholars in the early phases of their career, including <u>PhD candidates.</u>

<u>A maximum number of 20 early career scholars</u>, including PhD students, are selected (see details below), in order to allow an efficient management of group work.

The Organising Committee will further support and coordinate the group work.

## \* The first ECOLL Seminar

The first ECOLL seminar took place online on 20 May 2022, on "*The Status of Worker and Labour Law* – *Beyond Subordination?*", with the participation of Adalberto Perulli (Ca'Foscari University, Venice, Italy), David Mangan (Maynooth University, Ireland), Thomas Pasquier (Paris Nanterre University, France), Jesus Cruz Villalon (Sevilla University, Spain), and Manfred Weiss (Goethe University of Frankfurt, Germany).
